<u>Details of specifications / criteria for appointment of agency for providing 1 Data</u> Entry Operator for State Blood Transfusion Council, Mumbai

General Terms & Conditions.

- 1) The qualification and experience of the candidate provided should be as under:
 - Graduate, MSCIT with 1 year experience of Data Entry in any reputed organization
- 2) The agency will have to pay minimum wages as per the Minimum Wages Act to the candidate provided by the agency.
- 3) The rate quoted should be inclusive of provident fund, EFPS, ESI and other statutory payments.
- 4) It will be responsibility of the agency for payment of wages by cheque or NEFT to the employee before 10th of every month and also deduction of P.F., EFPS, ESI, P.T., Income tax, and other statutory deductions.
- The employee will have to work 8 hours, daily excluding weekly off and Govt. holidays. However, employee will not deny to work beyond 8 hours and holidays as per the exigencies of the office. In case employee has to work for extra hours no overtime payment will be paid by SBTC. The cost of the overtime, if required to be paid, will have to be borne by the agency.
