# **CIRCULAR**

Sub: Revising the format for giving NOC for renewal of license of the blood bank and Setting up of new blood bank on the lines of revised guidelines issued by NBTC, revising processing fees and delegation of powers for issue of NOC for setting up of new blood bank and renewal of license of blood bank.

The NBTC has issued revised norms for setting up of new blood banks and for renewal of the license of the existing blood banks as per the D.O. letter no. S.12016/1/2014-NBTC dt. 21<sup>st</sup> September, 2015 from Addl. Secretary, Govt. of India Ministry of Health and Family Welfare, New Delhi. Those norms have been adopted by the SBTC in its 33<sup>rd</sup> Governing Board meeting held on 29.02.2016. Those guidelines have been circulated amongst all blood banks and displayed on the website.

- 2. In view of revising the norms by the NBTC, the issue of revising format of No Objection Certificates for Setting up of New blood bank and renewal of the license of the existing blood bank was under consideration of the SBTC.
- 3. Now the Governing Board of SBTC in its  $37^{\text{th}}$  meeting held on 15.02.2018 has accorded approval :
- (1) To revise the formats for giving NOC for renewal of the license of the blood bank and setting up of new blood bank on the lines of revised guidelines issued by the NBTC. The revised Form 'A' Application for No Objection Certificate for new blood bank license and the revised Form' B' Application for No Objection Certificate for renewal of blood bank license are enclosed herewith.
- (2) To revise the processing fees of the application for setting up of New blood bank / renewal of the existing blood bank from Rs. 500/- to Rs. 5000/- (Rs. Five Thousand Only).

- (3) To delegate the powers for issue of NOC as under:
  - 1) For setting up of new blood bank: Governing Board. In case of urgency President SBTC can approve subject to ratification in the next meeting of the GB.
  - For renewal of license of existing: Director SBTC blood banks
- 4. This circular shall come into force with immedicate effect. This circular is also available on the website of the SBTC www.mahasbtc.com under download link.
